## **ABOUT NOVAS**

For more than 20 years, NOVAS has been dedicated to helping people in Ireland.

Our first service was established in 2002, offering temporary, supported, low-threshold accommodation in Limerick. Since then, NOVAS has grown significantly. We now support around 6,000 people every year in more than 30 services. As an Approved Housing Body, we provide over 300 social housing units to 700 tenants, ensuring equality and dignity for all.

NOVAS addresses the needs of people experiencing homelessness, housing insecurity, addiction, and social marginalisation through a comprehensive approach that includes Housing, Health, and Recovery. Recognising the complex issues behind homelessness, we strive to offer holistic, long-term solutions rooted in diversity and a strengths-based approach.

We provide a wide range of accommodation and support services to families and adults who are homeless or at risk of homelessness, emphasising sustainable housing as a key priority. Our services include both short and long-term accommodation options, along with outreach programs aimed at preventing homelessness and ensuring that people do not return to it, guided by a rights-based framework.

Our commitment to equality, diversity, and dignity underpins all our efforts, ensuring we meet the needs of our clients with respect and compassion.
